Any exercise or option assignment will be subject to commission based on the principal amount of the transaction.

Corporate & municipal bonds

Transactions in corporate and municipal securities will be transacted on a principal basis and include a fair market mark-up or mark-down, which will be reflected in the execution price of the security.

Government securities & agencies

Primary market U.S. Treasuries purchased directly at auction: \$60 per transaction (bills, notes, & bonds).

Secondary market transactions in government and agency securities will be transacted on a principal basis and include a fair market mark-up or markdown, which will be reflected in the execution price of the security.
