#### Examples:

*Disputing a late payment:* Provide the month and year showing late. Include the specific date the payment was made and the date it was pulled from your bank account.

*Balance is owed, yet account was paid off:* Provide the date it was paid off, how much the payment was, and when it cleared your bank account.

*Account isn't yours:* State the account was opened without permission and tell us as much as you can about the situation. It's also helpful to tell us if you've reported you're a victim of identity theft and/or contacted the police.
